The licensee who sells the seed to the farmer, collects the royalty, pays the USG Fee, and submits the GPOS information, is credited with a sale. The producing licensee reports the transfer on the transfer form to USG office. The price below is a starting point in negotiations between USG Dealers.

Any USG customer that purchases a combined 200 or more units of USG Enlist and or XtendFlex soybeans will receive a \$2 per unit rebate! Replants not included. USG will track all eligible customers with GPOS info and send the checks to USG Dealers to disperse after GPOS is settled between USG, Bayer, and Corteva Early November 2026.

USG will mail out a postcard Rebate ad in November to all USG current and past customers.

USG 2026 Soybean Replant Policy

\$5 for USGT Check Issued from USG to USG licensee.

\$30 for Xtend™ on approved replants from Bayer. Refunded to USG. Check issued from USG to licensee.

\$25 for Enlist E3™ on approved replants from Corteva. **Price discounted on replant seed sale.**

\$30 for XtendFlex on approved replants from Bayer. Check Issued from USG to USG licensee.

We suggest the USG Licensee contribute an additional \$5/unit in addition to the above USG replant.

USG Licensee who sold seed originally will refund to Distributor and/or Dealer the cost difference for the replant seed. All replants must be reported to the USG office by **July 25, 2026** to be eligible for replant credits.

Anyone having replant situations should contact the USG office for clarification on these procedures.

We encourage you to prepare in advance of the sales season by reviewing your past sales reports and possibly contacting customers to obtain their Bayer (XT, XF) and Corteva (Enlist) grower license numbers.
